Launch of Grassland, Savannah and Rangeland Coalition (GSR)





The GSR Coalition will:

- Build political momentum for the recognition of the pivotal role played by grasslands, savannahs and rangelands for food, people and nature with a view to increasing public and private investments to protect, restore and sustainably manage these landscapes.
- Ensure that the multiple benefits of grassland, savannah and rangeland restoration are accounted for as key contributions to land degradation neutrality (LDN), climate, mitigation, biodiversity protection, and food security.
- Restore at least 90 million hectares of degraded grasslands, savannahs and rangelands by 2030 to enhance food and freshwater security and become "nature positive".

POLICY DECISION: 10. 2: To continue supporting the development of new initiatives subject to the availability of resources, for the sustainable management and restoration of all degraded lands such as peatlands, grasslands and savannas to safeguard these threatened ecosystems and to ensure food and freshwater security for groups in vulnerable situations.

Opportunities to Influence Policies on Grasslands, Rangelands and Savannahs



Nature-based restoration and multipurpose use of rangelands

- <u>Action 1</u>: Stockholm+50 to call on countries to urgently stop conversion of rangelands, including grasslands and savannahs, and to restore 50% by 2030 through sustainable, participatory nature-based solutions
- Action 2: Stockholm+50 to call on countries and the private sector to ensure that deployment of large-scale renewable energy schemes in rangelands, including grasslands and savannahs, are mutually beneficial for pastoralists and ecosystems without unintended negative social and environmental impacts.
- <u>Action 3</u>: To strengthen a global coalition/platform for the sustainable stewardship and nature-based restoration of rangelands, including grasslands and savannahs (recently presented at UNCCD COP 15), securing sustainable livelihoods for all pastoralists and benefiting the planet.
